Our Analysis of Federal Government Spending between Jan-June 2023, shows that N3.19tn was disbursed to Ministries, Contractors and Personal Accounts. Further breakdown of these selected payments are presented in the subsequent pages

## Introduction

In July 2021, www.govspend.ng was launched by BudgIT Foundation to provide citizens with information on the total number of daily transactions made to Ministries, Departments, and Agencies (MDAs), as well as to contractors and personal accounts. Govspend platform is built on the data the FG provides via www.opentreasury.gov.ng

BudgIT presented a three-year trend analysis in its last report to show the total amount of daily payment transactions between years 2020 to 2022, with a total amount of over N14tr was discovered to be made to Ministries, Contractors and Personal Accounts, respectively, to execute a project for selected Ministries. For this report, we are diving into payment transactions made to Ministries, Contractors, Personal Accounts, Suspicious and Duplicate transactions scrapped from the opentreasury.gov.ng portal between January and June 2023.

In our analysis, a total amount of N3.19tn has been paid from Jan- June 2023 with daily payment transactions above N10m to Contractor's Account resulting to N11.5bn, daily payment transactions above N5m to Personal Accounts were N1.2bn and duplicate daily payment transactions above N5m to Ministries And Departments (MDAs) Accounts were N559m. Suspicious transactions above N10m to the Contractor's Account were N1.5bn with daily duplicate payment transactions above N5m to Personal Account were N2.6bn, followed by transactions without descriptions were N101m.

### Selected payments above N5m to Personal Accounts

In this section, we take a look at the top 18 transactions above N5m to Personal Accounts from Jan-June. Following the trend, it was discovered that the Office of the Special Adviser to the President on Niger Delta paid N17m to Dasimaka Adokiye Sami on February 2, 2023, Being the Payment of February 2023 Bulk Stipends to the 2802 Delegates of Ateke Camp as approved by the IA on 20/2/23. Dasimaka Adokiye Sami again received another payment of 182m on May 4, 2023, Being Payment of February 2023 Bulk Stipends to the 2802 Delegates of Ateke Camp as Approved by the IA on 20/2/23 from the Office of the Special Adviser to the President on Niger Delta. Again, the same Dasimaka Adokiye Sami received N186m twice from the same Office of the Special Adviser to the President on Niger Delta with the exact description of Being Payment of May 2023 Bulk Stipends to the Named Camp Leader for the 2802 Delegates of Ateke Tom on February 1 and June 5, 2023. This shows that Dasimaka Adokiye received into their personal account a sum of N728m, which leads us to ask a very pertinent question towards the identity of Dasimaka. Adokiye

In the same vein, Bello Nagwaggo received N40m from New Partnership for African Development on February 21, 2023, Being Payment of

Administrative Advances to Project Accountant for Hosting of Quarterly African Peer Review Mechanism (APRM) Governing Council Meeting with APRM Member State for Experience Sharing at Continental level and again Bello Nagwaggo received N63m from New Partnership for African Development on June 20. 2023 Being Payment made to Project Accountant for the Re-launch and **Domestication of AAUDA- NEPAD** Framework at the Federal. State, and LG level. Odiki Jacob received N33m from the Office of the Special Adviser to the President on Niger Delta on March 28, 2023, Being Payment of March 2023 Bulk Stipends to the 500 Delegates of Ekpomupolo Tobi Camp 1 in Phase 1.

On February 22, 2023. A payment of N17m was made to Joseph Evah from the Office of the Special Adviser to the President on Niger Delta Being Payment of Transport Allowances to NEPAD Staff and other Stakeholders as Administrative Advances to Project Accountant for a Workshop on the Conduct of 2nd Peer Review Process in Abuja.

All payments above raise eyebrows, as there are no proper mechanisms to track if these funds got to the intended use or if the government of Nigeria is just enriching some individuals.

### Selected payment from MDAs to Contractor's Account above N10m

Here, we followed the trend of payments made to contractor's accounts between January and June 2023. We discovered that N400m was made for Contingency (Bureau of Public Enterprises) from the Office of the Accountant-General of the Federation on May 25, 2023, with the description of Being the Release of Funds for N10bn IFO NIPOST and Subsidiary Companies for the Reform, Restructuring, and Modernization of NIPOST as Per AIE No. A01-00008715.

In the same light, Fowomaje Heritage Brothers received N13m from the Nigerian Correctional Service on February 17, 2023, with the description as Payment for Osun Ration Liabilities in December 2021. These transactions are way above N10m transfer cap to contractors' accounts in one transfer, which contradicts the guiding principle stated by the FGN.

### Selected duplictate payments above N5m from MDAs to Personal Accounts

As captured on the opentreasury.gov.ng portal to the govspend.ng platform, transactions reported on the daily financial spending of the government of Nigeria are generally within the stipulated limit of N5m to a Personal Account in a day by the Anti-money Laundering Act. However, some outstanding transactions to some selected individuals revealed a series of payments above N10m into these accounts. to June 2023, it was noticed that between February 2023 and May 2023, several duplicate transactions were made from the Office of the Special Adviser to the President on Niger Delta to Federal Inland Revenue Services. We also noticed duplicated transactions from the Nigerian Air Force to the Nigerian Airfoce Capital Account.



### Selected TOP leading (Spending ) MDAs Analaysis from Jan - June

The table below shows the top 10 MDAs with the highest spending from January 1 to June 1, 2023 (Q1-Q2) respectively. The Ministry of Defence spent N663bn on 954 transactions, and the Federal Ministry of Niger Delta with N526bn on 418 transactions, followed by both the Federal Ministry of Agriculture and Federal Ministry of Transport with N517bn on 1,635 transactions and N441bn on 322 transactions. According to these breakdowns, the Federal Ministry of Defence made the most payments in the review period than other ministries like the Federal Ministry of Education and the Federal Ministry of Health.


With this analysis, it's clear that issues around education and health take the back burner in the priorities of the Federal government. The federal government should take seriously Investing in these two important indices as they contribute to the macro and micro economy of the country. BudgIT advocates for more targeted investment in education and health systems as it's as important as investing in the country's defense. Selected Top 10 Ministries with high spending






For this section, BudgIT identified some ministries that were considered low in spending from January to June 2023. It starts with the Federal Ministry of Petroleum Resources, spending N6.8b on 684 transactions, and the Federal Ministry of Information and Culture with N5.5b on 260 transactions, followed by the Federal Ministry of Women Affairs with N4.2b on 260 transactions.

The Federal Ministry of Special Duties and Inter-Governmental Affairs and the Federal Ministry of Foreign Affairs were considered to have spent the least of the overall spending from January - June 2023.



In this section, we also discovered the Top 5 Department and Agencies with high spending from January to June 2023. The police command spent N344b on 555 transactions, with the Nigerian Army spent N319b on 114 transactions, followed by the Office of the accountant-general of the Federation with N143b on 1,317 transactions.




Top 5 Departments and Agencies from Jan - June 2023

## Conclusion

The citizens will be able to have a hand on what the country's resources are spent on, how it's spent and if the interests of Nigerians are at the centre of these expenditures.

In addition, citizens will better understand the government's activities, building public trust and confidence in this democracy. We believe BudgIT's work, as well as other Civil Society Organizations, will continue to demand more open government policies and push for value for money.



## Recommendations

To create an atmosphere of transparency and accountability, established rules governing how much can be sent to personal accounts, and for what purposes, must be strictly followed. As clearly seen in the table above covering January - June 2023, we have seen multi-million nairas paid into Personal Accounts on behalf of Ministries and Contractors. Some of these payments seem very suspicious, and it should raise the eyebrows of every Nigerian.
