

Insertions by the National Assembly in the **2025** Budget





Introduction

On December 18, 2024, President Bola Ahmed Tinubu presented an appropriation bill of N49.74 trillion for the fiscal year 2025 to the National Assembly. This represented an 80.96% rise compared to the proposed budget of N27.50 trillion for 2024. The National Assembly reviewed and approved the budget, which was subsequently signed into law by the President on February 28, 2025. The president increased the budget from N49.7tn to N54.2tn, which was then bumped up by the National Assembly to N54.99tn. This indicates a cumulative increase of N5.29tn.

A closer look at the approved budget shows that the National Assembly raised the recurrent non-debt budget proposal (which includes staff costs, operational expenses, pensions, gratuities, and other social benefits) by N299.75 billion, adjusting it from the proposed N8.58 trillion to N8.81 trillion. The recurrent debt budget (for debt servicing) was cut by N2 trillion, decreasing from the N16.32 trillion proposed by the executive to N14.31 trillion.

On the other hand, the National Assembly increased the capital expenditure budget by N9.11 trillion, raising it from the initial proposed N14.85 trillion to N23.96 trillion. This indicates that the National Assembly introduced new projects or boosted funding for existing allocations by over N9 trillion.

Distribution of Inserted Projects by Value

A total of 11,122 projects culminating in N6.93tn were inserted in the 2025 budget by the National Assembly, an ugly trend that was accelerated in the 9th National Assembly. The additional 3.18tn was added to the capital supplementation (see Appendix II), which makes up N9.11tn in capital projects. 238 of the projects worth N2.29tn are in the range of values greater than N5bn in value. We also noticed that 984 projects worth N1.71tn, and 1,119 projects within the range of N500m-N1bn, worth N641.38bn were inserted into the budget. We contend that the National Assembly has indiscriminately inserted projects into the national budget, many of which appear to serve narrow personal interests and political expediency rather than the broader public good.

Fragmentation of the Budget

3,573 projects worth N653.19bn are to be directly delivered in federal constituencies, while 1,972 projects with a value of N444.04bn are directly in senatorial districts. A deeper dive into project categories include 1,477 streetlights worth N393.29bn, 538 boreholes worth N114.53bn, 2,122 ICT projects with a value of N505.79bn, 319 health-related projects with a value of N420.09bn, and 6.74bn for the empowerment of traditional rulers.

Categorization of Insertions by Supervising Ministries

Thirty-nine percent (4,371) of the projects worth N1.72tn were inserted in the Ministry of Agriculture's budget, raising its capital budget from N242.50bn to N1.95tn. Recall that in a 2024 analysis, it was revealed that the National Assembly inserted 2,470 projects in the Ministry of Agriculture and Food Security, including several MDAs under it. In 2025, the National Assembly inserted 1,777 new projects valued at N994.98 billion into the budgets of ministries such as Science and Technology, while 90 additional projects worth N1.1 trillion were inserted into the budget of the Ministry of Budget and Economic Planning.

Insertions by Ministries, Agencies, and Departments

Certain agencies and organizations are targeted for these insertions. For example, the NIGERIAN BUILDING AND ROAD RESEARCH INSTITUTE, LAGOS, and FEDERAL CO-OPERATIVE COLLEGE, OJI RIVER, among others, have become the targets for National Assembly members to insert projects. Most of these agencies don't have the required technical capacity to execute the delegated projects, leaving a long list of poorly executed projects across the country.

Frivolous Items/Out of the Mandate of MDAs

Many agencies are executing projects that are out of scope and frivolous, thereby adding zero value to the country. Most of the projects are tied to the political value of the lawmakers and are indiscriminately added to the budgets of several MDAs. How will these agencies, without the requisite knowledge regarding these projects, properly monitor and appraise performance? A few allocations are provided below:

Recommendations

The President must assert greater executive leadership in ensuring that the national budget aligns with the Federal Government's medium- and long-term development strategy. This includes initiating a reform-oriented dialogue with the National Assembly to establish a transparent, equitable, and accountable process for the inclusion of constituency projects. The current practice—where lawmakers independently insert projects without coordination with national priorities—undermines the credibility of the budget and weakens the impact of public expenditure. Although unofficial claims suggest that Senators and Members of the House of Representatives receive N1 billion and N2 billion respectively for constituency projects, our analysis of project insertions reveals that actual allocations are often significantly higher. These discrepancies highlight the urgent need for budgetary reform anchored in data transparency, independent verification of project costs, and a standardized mechanism for tracking the implementation and impact of constituency projects. Without such reforms, the budgeting process risks being dominated by political patronage rather than national development goals.



A definitive judicial ruling is necessary to clarify the extent of the appropriation powers that the constitution grants to the National Assembly, especially concerning its ability to unilaterally introduce new capital projects in the budget. Over the years, there has been ambiguity regarding whether the National Assembly has the constitutional authority, through its powers of appropriation, oversight, and review, to add new projects (line items) into the budget proposal without involving the Executive. The continuance of this ambiguity further erodes the separation of powers, specifically regarding the extent of powers held by the National Assembly. The Attorney General and Minister for Justice can institute proceedings at the Supreme Court via a motion seeking the interpretation of the Constitution.

Recommendations

Inadequate Accountability Structures

Although constitutional and legal measures require accountability, the actual enforcement of these measures is lacking. Public officials are infrequently held responsible for corruption or mismanagement, resulting in ongoing failures in governance and service provision. The Economic and Financial Crime Commission and the Independent Corrupt Practices and other related offenses Commission need to prosecute cases of abuse, corruption, and financial recklessness associated with the budget process.

Incorporate Citizens and Civil Society as Essential Participants in the Budgeting Process

Drawing from examples of subnational units that have successfully engaged in 'Citizens' Budget Hearings', BudgIT believes that such involvement is crucial. Citizens and Civil Society should be included in the Approval Stage, as their inquiries regarding the Appropriation Bill (along with explanations for the budget insertions made by the National Assembly) could prevent unnecessary insertions from occurring in the first place. Both the Senate and the House of Representatives have committees for CSOs/domestic NGOs; these committees, headed by Senator Victor Umeh and Rep. Victor Obuzor can call for quarterly joint reviews of the implementation of the budget. Not only can CSOs bring their knowledge and capacity to engage in implementation assessment, but this process can be done at minimal cost through hybrid sessions.
